(i) In 2023, Travel Unity provided services, trainings, and workshops to many organizations to help them with their journey to be welcoming to people of all backgrounds and identities. Some of the organizations we worked with in 2023 included Mendocino Land Trust, Visit The Northshore, and Visit Greater Palm Springs. We also presented at ASTA, The Collective Experience, and to the Ontario Motor Coach Association. (ii) We began an in-depth revision of the DEI Standards for Organizations that we curated in 2020. (iii) Throughout the year, we convened monthly virtual meetings and supported the organizations and individuals that are part of the Travel Unity Alliance, a community for those committed to applied DEI in travel. (iv) Finally, Travel Unity ran booths at multiple Travel & Adventure Shows, as well as at the American Bus Association (ABA) and National Tour Association (NTA).

4b (Code:) (Expenses \$ 29,607 including grants of \$) (Revenue \$ 42,889)

Travel Unity held two Summits in 2023: a Southeast Summit in Lake Charles, LA and a Caribbean Summit in San Juan, Puerto Rico. Our 2023 Southeast Summit was introduced by Mayor Nic Hunter of Lake Charles, featured Sophia Hyder Hock of Destinations International as the keynote, and included an array of speakers from across the Southeast and beyond in both plenary sessions and two concurrent breakout tracks. Our 2023 Caribbean Summit was the kickoff of IGLTA's Global Convention and included both a thinktank session and panels + workshops. As part of the Caribbean Summit, through grants from SYTA and the SYTA Youth Foundation, youth volunteers were able to volunteer at El Yunque National Forest in Puerto Rico.

For our 2023 youth programs, Travel Unity focused on managing internships, along with building up the online Youth Volunteer Program (YVP) and Travel Unity Youth Advisory Council (TUYAC). Travel Unity's interns helped on pilot collaborations with Tourism Cares and Sage Inclusion. In YVP, students launched the Travel Cast podcast, where guests shared personal travel stories and insights on the travel industry. In TUYAC, two specialized committees - the Social Media/Marketing Committee and the Podcast Committee - helped shape our youth programming in 2023, providing both their insights and volunteer time.
